We distribute this information to foundations and nonprofits working on animal welfare issues and to the general public. In 2020 we published several original publications, and conducted hundreds of hours of research.

Longtermism: We research how to improve the likelihood that humanity survives into the longterm future, and how we might be confident that we can have an impact on the wellbeing of people over long time spans.
